• Functions & Responsibilities of Governing Body / Board of Governors:

Subject to the existing provision in the bye – laws and rules of the institute laid down as per the state government, the governing body of the institute shall have powers to:

- v. Appoint other central committees for effective discharge of responsibilities
- vi. Approve necessary issues related to development of the institution.

- vii. Recommend, when necessary, amendments, alterations, modifications deemed or repeal or add any new provision to the constitution and the Rules and Regulations framed there under to the various committees such as Academic Council with reasons therefore.
- viii. Lay down and implement Rules & Regulations regarding service conditions of all the employees and staff of the institute, staffing pattern, recruitment, pay scales, use of vehicles, etc.
- ix. Do all other acts and things as are necessary to carry out the vision of the institute.
- x. Delegate administrative, managerial, and financial powers to the Director and other functionaries in the institute for its smooth functioning.
- xi. Approve Annual budget and Annual Report of the institute.
- xii. Perform such other functions and constitute Committees, as may be necessary and deemed fit for the proper development and fulfil the objectives for which the institute was established.

• Frequency of meeting:

The Board of Governors meets at least twice in a year or as and when required. Notice of the meeting is issued by the member secretary to all the BOG members in advance. Quorum for the meeting shall be 50% of the body members. However, if there is no quorum for the meeting convened up to half an hour, then the meeting shall stand adjourned to the next convenient day. If in the meeting next to the adjourned meeting, there is no quorum for half an hour, then members present shall themselves constitute the quorum and shell conduct the meeting.
