

On completion of the formal introduction, the Director Dr. S. K. Jain presented the agenda of the meeting for discussion to the members. The minutes of the meeting are given below:

Following agenda were discussed:

#### 1. Re-Confirmation of the Governing Body Minutes of Previous Meeting.

Member Secretary presented the minutes of the previous meeting of the Governing Body held on 21.12.2022 to the members for their comments and confirmation. Resolved to confirm the minutes and there were no comments on the minutes of the meeting.

2. Appointment of New Director: It was brought to notice of members of Governing body that tenure of present Director of the Institute is going to be over by August 2023, therefore it is needed to finalize the next Director.

#### 3. Proposal of Faculty Requirement owing to Increased Intake.

Member Secretary presented the Academic Council's proposal of faculty requirement in different departments. It was approved for necessary action by director in view of next semester teaching load due to newly introduced programs.

#### 4. Review of the Budget Utilization of Financial Year (2022 - 23).

The Governing body reviewed the budget utilization and found it as Rs. 10.61 Cr against the budgeted amount of Rs. 10.132 Cr for the year 2022-23, budget utilization was 105 %. The Chairperson suggested that Academic Council should encourage the staff members to make proposals for organizing funds from Govt. /Non Govt. organization as may be available with them. All the members unanimously appreciated budget utilization and ratified noting the guideline suggestions.

## 5. Approval of Budget Proposal of Financial Year (2023 - 24).

Governing body members showed the satisfaction on the amount of budget for the year 2023-24 and unanimously approved an amount of Rs. 7.76 Cr and ratified the annual budget proposal of the institute for the year 2023 - 24.

### 6. Approval of Speeding up of Infrastructure

As per the discussion held in the meeting, it was unanimously approved the proposal of Academic Council for construction of required infrastructure in the Institute. Rs. 60,00,000/- was budgeted for infrastructure in 2023-2024 and unaudited expenses in session (2023 - 2024) is Rs 8318241/-.

## 7. Appraisal related to Counseling & Admission Procedure in the Institute.

Director presented the admission policies of 2023 - 24 and suggested that there is a need to implement the telephonic counseling process for the prospective engineering aspirants.. The Governing Body unanimously appreciated these implementations and approved to follow in the coming admission session also.

### 8. Approval of Proposals of Academic Council Regarding NBA of the Institute.

Member secretary presented the progress of accreditation work process as received from academic council for all the four departments of the Institute viz. CSE, ECE, EX & ME. The proposals from academic council have been deliberated in details and are ratified.

### 9. Appraisal of MOOCS - Massive Open Online Course Implementation

Member Secretary explained that the MOOCS system is implemented in the institute by taking existing courses and at least one MOOCS will be offered for the students. All the members appreciated the development and suggested to continue with more online courses.

## 10. NPTEL Course - Faculty Certification

- 3) Co-Curricular & Extracurricular and Sports Committee
- 4) Academic Results Monitoring Committee

The constitution and effective functioning of other committees like student welfare committee, GRC, ICC, committee for SC/ST and anti-ragging committee were emphasized by members.
